Explanatory Note

(This does not form part of the Notification, but is intended to indicate its general purport)

As per Rule 30 of Transplantation of Human Organs and Tissues Rules, 2014, and Section 13A of the Transplantation of Human Organs Act (inserted vide the Transplantation of Human Organs (Amendment) Act, 2011), the Central and State Government, by notification, shall constitute an Advisory Committee for a period of two years to aid and advise the Appropriate Authority to discharge its functions.

Hence the Government have decided to constitute the Advisory Committee to discharge its functions under the Transplantation of Human Organs Act, 1994.

The notification is intended to achieve the above object.
